Dear TBE Family: It is hard to believe but this will be Rabbi Singer's 12th High Holy Day service at TBE and Cantor Bob's 45th! This letter provides you with the information you need regarding our High Holy Day services. **Please note that we have made some changes to our Children's Service schedule as well as to our Child Care program (please see schedule and form below).** We are not issuing paper tickets. Congregants will be able to walk in and non-members, including adult children and parents of members, will need to check in. Their names will be on a list at the registration table.

If you had a baby during the past year, Mazel Tov! Call us if you would like to participate in the Baby Welcoming on Rosh Hashanah morning. If you became Jewish during the past year and would like a blessing during this service, please contact the Temple office as well.

CHILDREN:

We welcome all members and guests to our services. We ask that parents sit with their children - including teenagers - so that they can supervise their children's behavior. Please help us preserve appropriate decorum and respect; if children become noisy, please take them out of the sanctuary. For their safety, children are not permitted in the foyer or outside the building without adult supervision. Temple Beth El Sisterhood offers childcare during the morning services for parents who wish to attend. **This year, teachers from our Religious School will be providing educational resources on the holidays for children in the childcare program.**

CELL PHONES AND OTHER ELECTRONIC DEVICES:

Our sanctuary is a sacred space. In order to preserve its sanctity, we ask that all electronic devices be turned OFF or put on vibrate. This will allow everyone to engage in prayer in a meaningful way.

THE TORAH:

It is not appropriate to walk in or out while the Torah is out.

SEATING:

- There are some seats in Temple Beth El's sanctuary that have been reserved in perpetuity, and will be designated as such.
- You can purchase reserved seating for all four (4) 5779 High Holy Day services at \$180/person.
- All other seats will be available on a first-come, first served basis. At least ½ of the sanctuary seating is available unreserved.

Please complete the entrance request form on the **reverse side** and return it to the Temple **before Friday, August 24**. Forms requesting guest entrance or entrance for adult children or parents must be returned with a check for payment in full unless the guest is a *first timer* at TBE. First timers may come free of charge. If a guest is a member of a URJ congregation we will honor the written request from that Temple to allow reciprocal entrance at no charge. The request form may be mailed or faxed to us prior to the High Holy Days.

Please note: You may purchase reserved seating in the Sanctuary for all four (4) of the 5779 High Holy Day services at a charge of \$180/person.

Only members in good standing may request entrance for themselves and their children. All requests are subject to approval by the Finance Committee. If you have a concern regarding the status of your account please contact Harry Freedman before Friday, August 31. For security reasons, only congregants or guests with current ID who previously requested entrance and are on our registration list can be admitted into services.

Reduced price entrance is available for those in financial need. Please contact the synagogue office to request reduced-price admission or, if you have any questions, we will put you in touch with the correct person.

Temple Beth El's Sisterhood is again sponsoring childcare during Rosh Hashanah and Yom Kippur services if enough families are interested.

We are employing early childhood teachers from the Temple Beth El Child Development Center to watch our toddlers during all our services, and Religious School teachers to provide educational resources to our older children during the morning services only.

Upon completion of the service, parents must pick-up their children. No 'drop-ins', please. Only pre-registered children can participate in this childcare, so please remember that **we will provide daycare to Registered Children Only**.

Please note that while snacks will be provided, EACH CHILD SHOULD BRING A LUNCH FROM HOME.
